This letter must be dated after 10/1/2022.
  - **If you are an independent student**, you must attach the IRS Non-filing Letter.
  - **If not attached, your signature certifies that you attempted but were unable to obtain a non-filing letter from the IRS.**
- **LIST BELOW** every employer even if the employer did not issue a W-2 form. *If you need more space, attach a separate page with your name and Student’s ID.*
