Funding from the Born to Be a Warrior Scholarship will cover the gap between the full cost of tuition and standard fees (matriculation, registration and student service fees) minus federal grants, state scholarships and grants, WSU tuition benefits and other university scholarships and grants.

Step 1 File the **2025-26 Free Application for Federal Student Aid (FAFSA)** online at studentaid.gov/fafsa.

Step 2 Complete your [Employee Tuition Assistance Application or Spouse/Child Tuition Benefit Application](#) and submit it to Human Resources.

Step 3 Complete this 2025-26 Born to Be a Warrior Merit Scholarship Application and **submit it to the Office of Student Financial Aid**.

Award requirements: This award is open to new and currently enrolled WSU students who meet the award requirements.

- The student must be the child or stepchild of a current full-time Wayne State University employee
- Freshmen must have a 3.5 high school GPA at the time of admission.
- Transfer students must have a cumulative 3.0 GPA from their current college or university and a 3.5 high school GPA at the time they graduated from high school.
- The scholarship is for undergraduates who do not have a bachelor's degree.
- This award is disbursed during the fall and winter semesters to students who attend full-time (12 or more credit hours)
- Complete the [2025-26 FAFSA](#).

Current WSU students: In addition to the above criteria, you must have a cumulative WSU GPA of at least 3.0.

Renewal requirements:

This award is renewable for up to four years, with the option to apply for a fifth year, provided you are on track to graduate.

1. Meet all Satisfactory Academic Progress requirements and maintain full-time enrollment
2. Maintain a minimum 3.0 cumulative GPA and pass at least 30 credits each academic year
3. Complete the [2025-26 FAFSA](#) and the [Employee Tuition Assistance Application or Spouse/Child Tuition Benefit Application](#).
