# SPRING SESSION MAY 10-JUNE 25, 2021

Examinations for the Spring Session will be held <u>Monday, June 28 and Tuesday, June 29</u> at the regularly scheduled class meeting times. Classes meeting four days a week may schedule examinations on both days. Classes meeting Monday - Wednesday pattern will hold their exams on <u>Monday, June</u> <u>28</u>. Classes meeting on a Tuesday - Thursday pattern will hold their exams on <u>Tuesday, June 29</u>.

# SPRING/SUMMER TERM MAY 10 - JULY 30, 2021

Examinations for the Spring/Summer Term will be held <u>Monday, August 2 through Thursday, August</u> <u>5th</u> at the regularly scheduled class meeting times.

# SUMMER SESSION JUNE 30 - AUGUST 17, 2020

Examinations for the Summer Session will be held <u>Thursday, August 19 and Friday, August 20</u> at the regularly scheduled class meeting times. Classes meeting four days per week may schedule examinations on both days. Classes meeting on a Monday - Wednesday pattern will hold their exams on <u>Friday, August 13</u>. Classes meeting on a Tuesday - Thursday pattern will hold their exams on <u>Thursday, August 12</u>.

For classes, which do not meet on Monday or Tuesday, the instructor should determine when the class could best meet and email Registration and Scheduling, scheduling@wayne.edu for a room.

# Principles Governing the Final Exam Week Schedule:

All classes meeting at 4:00p.m. or later will hold final exams during their regular meeting period in the final exam week and be limited to their scheduled hours. Requests for extended hours will be granted if a classroom is available and the instructor has determined that the extended hours will not cause students a conflict with their other final exams.

Any deviation from the final exam schedule must be initiated by the instructor, approved by the instructor's dean and scheduled through the Scheduling office. Requests for extended hours will be granted if the instructor has determined the extended hours will not cause his/her students to have conflicts with other final examinations.

Students are not required to take more than two exams in one day. A student with more than two scheduled final exams on one day may (not must) petition to the instructor of the course with the lowest number students enrolled, to arrange an alternate time for the final exam. Such petitions must be made at least one week prior to the scheduled date of the final exam.

In situations where conflicts exist between the regular day schedule and the group exam schedule, the group exam takes precedence. If there is a conflict among the regular schedule, group exam and evening schedule, the group exam takes precedence. The instructor with the fewest students in the remaining two classes will offer alternate arrangements to students.

Any student unable to take a final exam at the scheduled time due to religious convictions shall petition the instructor in advance of the final exam to arrange an alternate time.
